WHEREAS prior to the execution of this trust deed, a sum of Rs.5000/- [~~Rupees~~ Five Thousand Only] was handed over to the trustees by the founder and the trustees do hereby admit to be held by them in Trust together with further Donations, Contribution and property that may herein after be transferred to the trust by the founder or others and interest, Rent, Dividend, Profit and other income thereof for the object and the purpose hereinafter mentioned subject to the provision hereinafter declared and contained of and concerning the same.

NOW THIS DEED OF INDENTURE WITNESSETH AND HEREBY AGREED AND DECLARED AS FOLLOWS.

[1] NAME OF THE TRUST

The Trust hereby declared and constituted is a Public Charitable Trust and shall be called "DIL SE".

[2] ADDRESS OF THE TRUST

The Trust shall be at present located at the following address namely:

V.B. Royal, C-12, 49, Edappally.P.O. Ernakulam - 682 024. The address can be changed to any other place decided by the Board of Trustees from time to time.

[3] AIMS AND OBJECTIVES:

The Aims and Objectives for which the Trust shall render charitable services are solely for philanthropic purposes and not for the purposes of profit, and that too irrespective of sex, caste, creed, community and religion and such services shall specifically include.

[a] To establish, run, maintain, improve and develop Educational institutions and Balwadies without any motive for profit and to undertake already established similar institutions. To develop creativity in children and give them food, shelter etc.

[b] To run orphanages and institutions for the poor children.

[c] To facilitate community based rehabilitation of street children.

[d] To help the children from single parent families in their education and training.

[e] To bring awareness among the street people and poor people about hygienic life, family planning and such other social reforming measures.

[f] To raise awareness about peace among people.

[g] To bring awareness about Ecological issues and facilities, ecological projects, such as organic farming, solar energy, etc.

[h] To take care of poor and street children, until they join with their family members in the appropriate time and appropriate manner, by giving accommodation, food, dress and medicine as circumstances warrants.

[i] To educate people, children so as to have self-confidence, optimism, morality, courage, social awareness, politeness etc.

[j] To help the street children to continue their school/college education.

[k] To give proper job-oriented training and guidance to the poor youth, to achieve their daily bread through some self occupation.

[l] To identify people especially children, who happen to be on street, and understand the circumstances which made them be there.

[m] To accept donations, gifts, presents, aids and grants in cash or kind and movable or immovable properties from the Public in India and Abroad, State and Central Government, either as corpus or as income according to the directions of the donors for the purpose of carrying out the object of the trust.

[n] To do all such other lawful acts as may be necessary and or incidental and conclusive to the attainment of the above objectives or any one of them.

[o] To provide relief to the poor, education, medical relief and advancement of any other object of public utility.

[p] To operate such activities for the benefits of the street and destitute people in a similar way in other parts of the country, by starting branch institutions.

[q] To bring together and co-ordinate the activities and to affiliate organizations working for the welfare of youth women and children.

[r] To work with H.I.V. infected and affected people by running orphanages, spreading awareness programs, giving medical support etc.

[s] Providing training and workshop for people studying or working in different fields of social works, health, education, ecology and interested in the objectives of this trust.

[4] INVESTMENT.

The investment of the Funds of the Trust shall be made in accordance with the provision of the Section 11 [5] read with Section 13[1] of the Income Tax Act.

[5] AMENDMENT.

The Board of trustees is entitled to amend the trust deed as per majority decisions. The power to amend would not extend to altering the basic character/objectives of the Trust and further, no such amendment which may prove to be repugnant to the provisions of Sections 2[15], 11, 12 and 13 and 80 G of the Income Tax Act shall be made.

[6] ACCOUNTS AND AUDIT

The Accounts of the Trust shall be regularly maintained and every year, the accounts shall be closed by 31st March and the same shall be audited by a Chartered Accountant.

[7] UTILISATION OF FUND.

The Income and Funds of the trust will solely be utilized towards the objectives and no portion of it will be utilized for payment to the Trustees by way of profit/dividend/interest etc.

[8] DISSOLUTION OF TRUST.

In the event of dissolution or winding up of the Trust, the assets remaining as on the dissolution shall under no

circumstances be distributed among the trustees or members of the Managing Committee or Governing Body but the same shall be transferred to another charitable trust whose objectives are similar to those of this trust and which enjoys recognition u/s. 80B of the Income Tax Act.

[9] OPERATE WITHIN INDIA.

The objectives/Activity of the Trust shall be carried out only in INDIA.

[10] NON PROFIT BUSINESS:

The trust will not function in the nature of conduction of business activities and not for the purpose of profit it would satisfy the conditions laid down in Sec. 11[d] and provision to Sec. 80G [5][1] of the Income Tax Act.

[11] BOARD OF TRUSTEES.

[a] The Founder of the Trust hereby constitute nominate and appoint the Board of Trustees.

[b] The total strength of the Board of Trustees shall be six. The strength of the Board of Trustees can be increased up to nine as per the majority decision of the Board of Trustees and those vacancies can be filled by the Board of Trustees by appointing suitable persons.

[c] Mr. Ravinder Pal Singh who is the Founder of this Trust shall be the first Managing Trustee and he shall be entitled to continue as such for a period of one year or to extended time decided by the Board of trustees.

[d] The other trustees will act as Trustees for the period of 3 years from his date. They may be reappointed for further periods as per the majority decisions of the Board of Trustees. The period of Managing Trustees is one year from the date of selection. The Board of Trustees shall elect one among them as Managing Trustee. A Managing Trustee can be removed from that post as per the majority decision of the Board of Trustees and a new Managing Trustee can be selected.

[e] In the case of death, resignation etc, of the Trustees, the Board of Trustees has the power to appoint any person in his/her place by majority decisions.

[12] MANAGEMENT.

With a view to carry out the objects of the Trust, herein above mentioned and to submit its funds and administer them and in the discharge of their duties, the Board of Trustees shall have the following power.

[a] To receive upon such terms and conditions as they may deemed, fit, donations, gifts, subscriptions in cash or kind from the public, institutions, Government and Quasi Government agencies and similar bodies in and outside India for the said objects of the Trust.

[b] To invest funds from time to time in such securities and in such manner, as may be deemed fit, to alter or vary the investments from time to time, to realize the investments, to

acquire or to sell securities, stocks and shares provided no investment would be made which would violate the provisions of Section 11 [5] of Income Tax Act, 1961.

[c] To sell or dispose of any property, movable or immovable of the Trust and the moneys arising from such sale or disposal shall be deemed to be part of the Trust Fund.

[d] To borrow for the purpose of the Trust on the credit of with or without charge, upon any of the assets of the Trust.

[e] To meet all the necessary expenses incurred or to be incurred in connection with the management of the Trust.

[f] To open and maintain accounts of any nature in any Nationalized or Scheduled Banks or any other bank approved by the Reserve Bank of India and shall be operated jointly by the Managing Trustee and Financial Trustee.

[13] MEETING OF THE BOARD.

[a] There shall be an annual meeting of the Board to be conducted on or before 30th April of every year. In addition to the annual meeting, the Board may meet from time to time.

[b] The meeting shall be convened by the Managing Trustee of the Trust and the Managing Trustee shall preside over the meetings.

c] The Board shall transact any business that may be specified in the Agenda or otherwise agreed to by the Board members. The Board of Trustees shall elect one among them as the financial trustee.

[d] The Board shall also appoint a C.A. Auditor at the annual meeting for the subsequent year.

[e] One half of the Board members or four members of the Board whichever is higher shall constitute the QUORUM.

[f] All decisions shall be carried out by the majority decisions of the Board, but in the event of equality of votes, the Managing Trustee presiding over the meeting shall have an additional casting vote.

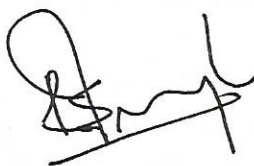
[g] The meeting of the Board shall be convened after giving at least a week notice unless those who are entitled to receive notice agree to accept a shorter notice.

[h] The Managing Trustee may invite others interested in the work or the Trust to attend the meeting of the Board, but they shall not be entitled to vote.

[i] The proceedings of the Board meeting shall be entered in a minute's book and shall be signed by the Managing Trustee. Managing Trustee is the custodian of all books and records belonging to the Trust.

At present there is no movable or immovable properties to this Trust except the corpus amount of Rs.5000/- of this trust.

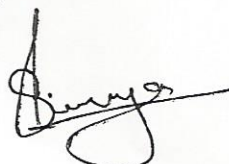
